Founded in 1911, the St. Louis Society for the Blind and Visually Impaired is a nonprofit, 501(c)(3) tax-exempt organization. We work each day to ensure that our community is a place where vision loss is not a barrier to living a full life.

Serving nearly 1,200 clients annually, each receives a plan of care designed to meet their individual needs through programs and services that include:

- The Drews Low Vision Clinic staffed by Doctors of Optometry and Low Vision Occupational Therapists
- Comprehensive and personalized vision rehabilitative therapies
- Orientation and mobility skills and strategies to navigate in the home and community
- Demonstration and training in a range of assistive technologies, as well as instruction in Braille
- Transportation to medical appointments, social and family commitments, and for other daily needs
- Support groups, community resources and referrals
- Cultural and social activities throughout the year, including peer groups that create opportunities for learning and sharing common interests
- Sight Solutions Shop offering a wide range of vision aids
